The Franklin Farmers Market is a year round market, opened every Saturday with two six month seasons (Summer Market which runs from May to October, and Winter Market which runs from November to April). Operating hours for Summer Market is 8:00am – 1:00pm May through October.

Vendor Booth Rental and Pricing Structure

Full season vendors commit to the full 27 weeks of summer market, paying in full by June 18, 2016. Part time vendors reserve booth space week to week depending on when they are available and pay the week they attend market. Also, part time vendors will be assigned a booth space based on availability.
